Terms and Conditions

1. Organisers

The SG60 Fun Discovery Trail ("Activity") is organised by SBS Transit Ltd, in collaboration with SimplyGo Pte. Ltd. and Singapore Polytechnic ("the Organisers").

2. Duration and Mechanics

- 2.1 The Activity will run from 28 September 2025 to 31 October 2025 (both dates inclusive) ("Campaign Period").
- 2.2 The Activity involves playing a game ("Zibble's Stamp Quest") on a dedicated web application and requires participants to visit the designated Downtown Line (DTL) and North East Line (NEL) MRT Stations to collect 16 digital stamps.
- 2.3 By taking part in this Activity, you agree to be bound by these Terms and Conditions and the decision(s) of the Organisers in relation to or in connection with the Activity.

3. Participation and Safety

- 3.1 Participants take part in this Activity at their own risk and are responsible for their own personal safety during the Activity.
- 3.2 Participants must not obstruct station operations, signage, or cause inconvenience to other commuters.
- 3.3 Participants are expected to remain respectful and courteous to station staff, fellow participants, and members of the public at all times.



4. Data Privacy

4.1 No personal data will be collected throughout the course of the Activity.
In instances where prize redemption is applicable, no personal data will be required beside basic verification of completion (i.e show unique redemption code on game screen on the web application).

5. Liability

- 5.1 The Organisers shall not be held liable for any injury, loss, or damage to property sustained by participants during the Activity.
- 5.2 Participants agree to indemnify and hold harmless the Organisers from all claims, expenses, damages, liabilities and/or costs (including those asserted by third parties) arising directly or indirectly from their acts, errors or omissions from engaging in the Activity.
- 5.3 Participants shall be solely responsible for their own belongings, transportation arrangements and well-being throughout their participation.
- 5.4 Participants shall not violate any applicable law, rule, or regulation (including but not limited to the laws of trespass) while participating in the Activity.
- 5.5 Participants acknowledge that the Activity requires mobile data for access and gameplay on the dedicated web application. All data charges incurred from participation shall be borne solely by the Participants. The Organisers shall not be liable for any costs, charges, or expenses (including but not limited to mobile data or roaming charges) incurred by Participants in relation to the game.
- 5.6 Participants are fully responsible for their own game progress during the Activity. The Organisers shall not be held liable for any loss of game data hosted on the web application. Participants have been advised not to delete their game cache or browser history, and not to play the game using Incognito or Private Browsing modes, as doing so may result in data loss or reset progress. In such event, the Participants do not have any right to demand that game progress be restored.



6. Amendments and Rights

- 6.1 The Organisers reserve the right to amend these Terms and Conditions, or modify, suspend, or terminate the Activity, in whole or in part, without prior notice. In the event of any inconsistency between these Terms and Conditions and any marketing or promotional materials relating to this Activity, these Terms and Conditions shall prevail.
- 6.2 All decisions made by the Organisers in relation to the conduct of the Activity, including eligibility and prize matters, are final and binding. The Organisers have the sole discretion to exclude any person from participating in this Activity without any obligation to furnish any notice and/or reason. No correspondence will be entertained.
- 6.3 The Organisers reserve the right to investigate complaints or reported violations of these Terms and Conditions and to take any action they deem appropriate, including, but not limited to reporting any suspected unlawful activity to law enforcement officials or regulators and disclosing any information necessary or appropriate to such persons.
